### TERMS AND CONDITIONS

All commercial loads are weighed on entry to the site (unless under prior agreement with Management). Car Trailers are charged by the load. Mixed loads are defined as containing more than one material; any mixture of concrete, brick, asphalt and or clean fill. All loads will be defined at the discretion of the gate operator. All materials entering site will be rigorously inspected on entry and during the unloading process. No unauthorised materials are to enter site, NO asbestos whatsoever will be tolerated. In the case of asbestos being found, the entire load will be treated as contaminated and will be charged at \$200 per tonne or load; Waters Excavations Pty Ltd will arrange disposal by a licensed company. A warning will be issued and you may be banned from entering the site if a second offence occurs. Other unauthorised materials include but not limited to: cement sheeting, plasterboard, plastic & general waste (1-2% tolerance). You may be rejected / banned from site if found bringing in any unauthorised items. Fines may apply. Payment is due immediately and prior to unloading unless a 30 day pre-approved account has been set up and approved, overdue accounts will incur fees. We accept cash or EFTPOS (1.25% Surcharge applies for all EFTPOS transactions). NO CASH IS KEPT ON THESE PREMISES OVERNIGHT. This site is under constant surveillance.
